What private data protection requests to we support?

Be Slavery Free recognises the a person's right to request the following personal data responses, and within the limits of our organisations resources we will seek to respond effectively to them:

- The right to access You have the right to request Be Slavery Free for copies of your personal data.
- The right to rectification You have the right to request that Be Slavery Free correct any information you believe is inaccurate.
- The right to erasure You have the right to request that Be Slavery Free erase your personal data, under certain conditions.
- The right to restrict processing You have the right to request that Be Slavery Free restrict the processing of your personal data, under certain conditions.
- The right to object to processing You have the right to object to Be Slavery Free's processing of your personal data, under certain conditions.
